2.1. Classification of the substance or mixture

Section 4: First aid measures

4.1. Description of first aid measures

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Do not use water. Alcohol resistant foam. Carbon dioxide. Dry chemical powder. Use water spray to cool containers.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: Extremely flammable. Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide.

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.
