Directions for Storage and Use

- Shake aerosol well before use.
- Test compatibility with painted or coated surfaces prior to application.
- Apply from a distance of 15 30 cm.
- Allow sufficient time for the foam to penetrate the • contamination (typically 15 seconds).
- Wipe the surface clean with a damp cloth.
- Repeat the above cleaning procedure if required • (indicated by the complete breaking of the foam).
- Rinse cleaned surfaces with potable water before • returning to the processing area.
- Use only in well ventilated areas and do not apply to very hot surfaces.
- Store below +50°C, out of direct sunlight.
- Shelf life is 2 years from date of manufacture.
- Consult safety data sheet before use.
